Structure

- Each school may bring max. **SIX STUDENTS** to the competition (TWO teams of 3 students). Students may complete in either **Entrepreneurship case or Personal Finance** case (preferably one team in each category)
- Prior to the competition, participants will receive a presentation template and the competition marking guide.
- All teams will have 3-3.5 hours to prepare their case analysis and presentation for the first round of judging. Teams will have 10 minutes to present followed by a 5 minute question period. Judges will include faculty from the U of R and U of S, sponsors, & members of the business community.
- **Teams are asked to bring a school laptop(s)** to create their presentation. Students will use that laptop for their presentation.
- In order to ensure anonymity of the teams and impartiality of the competition:
 - Teams will not be known by their school names during their presentations
 - Each team must come up with a fictitious name for the competition (ie. Everest Consulting)

Payment Information Team fees and teacher fees may be paid by cheque or with a credit card.

Student Fees

Team of 3 = \$195 total (\$65 each student)

Includes: all conference activities, accommodation, meals (Thursday supper and evening social, Friday breakfast, lunch and snacks)

Rooming & Transportation

<u>Each out of town</u> team will have a max of TWO (2) student hotel rooms. If you require more than the allotted student rooms, please book an additional room through the Saskatoon Inn & Conference Center on your own. Teachers will not be rooming with their students, but are responsible for their students while at the event. Out of town teachers will have their own rooms with their registration (\$195). If you require an additional "chaperone" room, you are required to contact the Saskatoon Inn and book on your own.

Teachers will be responsible for transporting students to the hotel on Thursday and to the University on Friday morning where the students stay for the remainder of the day.

Food and Beverages

Please specify if there are any dietary restrictions for any of the participating students when submitting student names (to be requested upon acceptance into the event). Thursday banquet, Friday breakfast & lunch are included. Students are advised to bring a refillable water bottle.

Dress & Attire

Thursday banquet dress is business casual. Examples would be dress pants, button up shirt & tie. *Team pictures will be taken on Thursday at the banquet.* Friday is business casual for case presentations. Dress to impress!

Scholarship Opportunities

Edwards School of Business, University of Saskatchewan in Saskatoon is offering \$2,000 for winners of either competition, \$1,500 for second place of either competition and \$1,000 for participants of the event, up to a total combination of \$20,000 in awards. *These scholarships are only applicable to grade 12 students who immediately enter the school in the upcoming fall and pursue the B.Comm. degree only (not applicable for any of the Certificate programs).* The awards are generously sponsored by the Edwards School of Business Dean's Circle.

Paul J. Hill School of Business, University of Regina in Regina is offering a \$2,000 entry scholarship (maximum 18 awarded – paid over 4 years) to all 1st, 2nd plus 6 Dean's Awards of \$2,000. To be eligible for this scholarship winners must attend the University of Regina.
